3. Presentation from the host country

Angel Plans Cañamares, the president of Catalan Society of Occupational Medicine and Pedro Gonzalez de Castro, the president of the Spanish Society of Occupational Medicine, presented the actual situation of occupational medicine in Spain (file 1, file 1.1).

4. Minutes of the last meeting (Innsbruck, 14.04.2012)

Secretary of the Section reported also on many activities to acquire all 27 EU member countries to join our UEMS Section. We have already got active representatives from 21 EU Member States, Switzerland and Croatia, the activities are continuing.

7. Tasks of Working Groups (WG)

WG 1 - TRAINING AND CME (Chair: Nikki Cordell)

- 1. The Code of Practise for Continuous Medical Development Accreditation Committee (CMDAC) Occupational Medicine Section UEMS has been finished. The money for EACCME activities will not be provided until the UEMS subaccount is opened in Brussels.
- 2. Chapter 6 of the Training Charter for Occupational Medicine is taking into account new insights in this field and has already been prepared for the UEMS Council. We need to put the data into the new template provided by the UEMS.
- 3. The secretary of the Section was invited to regular CESMA meeting that was held on 3rd May 2012 in Ljubljana. European Exam in UEMS Specialties is advancing and we were invited to take our part in this process. To make the situation clear we are going to invite the president of CESMA Dr. Zeev Goldik to our next Section meeting, probably in Luzern.

WG 2 - POLITICS (Chair: Jacques van der Vliet)

- On Friday, our special guest Viktor Kempa, a Senior Researcher from ETUI, presented visions and problems of working environment regarding European Health and Safety Strategy 2013 – 2020 (<u>files 2, 3</u>). The discussion in EU has been postponed.

• The systematic review for evidence based decision making on European Working Time Directive has not been finished so far. There are some statements in the "Implications for policy makers" and "Conclusion" sections where agreement of all the authors has not been achieved yet.

WG 4 - RULES OF PROCEDURES (Dick Spreeuwers)

- They are adapted to UEMS Rules of procedures.
- Next elections of the Board of UEMS Section of occupational medicine need to be carried out in spring 2013 (Dresden).

- Thomas presented the Meeting of the German, Austrian and Swiss Section of Occupational Medicine that will be held in Bregenz, 13.-15.03.2013), he, Klaus and Christine invited us to have presentations on our National Sections and problems on Saturday, 15th March 2013, when the program will be carried out in English language. 12. Finances

- Annette sent the financial report. We spent a certain amount of money for the activities that has been very successfully carried out.
- Annette is asked to send invoices for the fees 2012 and 2013. She should investigate whether a fee of 150,00 EUR per year is the fee per member or fee per country (including two members).
- The fees should be harmonized with UEMS rules for full members, associate members and observers.
- After the meeting of UEMS treasurers we are going to decide on UEMS subaccount.
