Dick gave an interesting presentation of Occupational Health Services in the Netherlands. The number of population in the Netherlands is 17 million, the number of active population 7 million. There is 60 000 physicians and among them 2000 occupational physicians. The founder of the Dutch occupational medicine was dr. Samuel Senior Coronel (1824-1892). From 1994 to 2006 commercial OHS and sickness absence were a core concept, since 2006 sickness absence has become less dominant, dominates looking for new services and advances to curative care. His presentation is added to the Minutes.

- 4. Joint efforts will be held with EASOM and Andre Weel.

7. Accreditation System of UEMS

On 6th April Jacques sent us all a proposal about accreditation requirements (file attached). We had an intensive and high quality discussion. Credit system evaluates the presentations and not the accepted knowledge but nevertheless it is the only simple and transparent system that can be applied all over Europe. It was accepted that until Bucharest meeting Andre Weel prepares the proposal how to nominate the accreditation committee of our section. UEMS has already prepared criteria!

8. ECAMSQ and other information on UEMS

Secretary General of the UEMS Dr. Bernard Maillet presented a very clear and interesting presentation of the activities of the UEMS-EACCME (File attached). Revision of the Directive on Mutual Recognition of Qualification has to take new concepts into consideration. UEMS website follows continuous improvements. UEMS Accreditation System should replace the National Committees as a final aim. Fees take into account the number of the participants. Occupational Medicine is mentioned in the Annex to the Directive 2006/100. It is recognized as a basic specialty in 26 Member States. The minimal length for training mentioned is 4 years.

9. Research projects

- Dick shortly reported on Publication Survey National Societies of Occupational Medicine (Consol, Mari Cruz, Dick) it has to be adapted to satisfy the demands for publishing in a proper journal.
